Their project: “Ritagli d'arte. Nuove declinazioni del riuso” / Art Cut-outs. New re-using ways”.

In collaboration with the Galassia Firm from Parugia, manufacturer of cashmere wool and high quality items, the artists, teachers and students have transformed into Art the waste of the industrial process, usually going to landfill or at best used in the production of low quality by-products.

Apart from our engagement in international art and cultural projects, some members of the association have a long-standing experience in managing and participating in EU projects in the area of education (Comenius, Grundtvig, Leonardo da Vinci, Erasmus Plus).
